Responsibilities (but not Limited to):

- Provides supervision, coaching, modeling, engagement, and support of students in living, activity, school and community settings
- Instructs, organizes, and assists students with carrying out daily living activities, recreational
 activities, developing self-care skills (health/hygiene), learning and practicing social and peer
 interaction, community interaction and coping skills, budgeting for small personal expenditures,
 and schoolwork and/or homework
- Informs appropriate staff of students' activities, behaviors and medical concerns. Completes and utilizes all agency forms as outlined in agency policy and procedure
- Coordinates with team members to plan and implement on- and off-ground activity schedules and events for students. Organizes, time, space and people to promote the activity schedule
- May be responsible for completing medication administration and/or assisting students with meal planning and preparation, laundry, and daily housekeeping

Qualifications:

- Age 21 or older required
- High School Diploma, GED or equivalent required
- Demonstrated ability or potential to work with individuals with special needs in a therapeutic and supportive environment required
- Experience in residential treatment or working with individuals with special needs preferred

- Demonstrates an ability to exercise good judgment and effectively solve problems
- Remains calm under pressure and maintains self-composure/self-control in times of high stress or when others are excited
- Effective working alone and as a member of a team.
